
Training for Success 2008-2009

MEASURE Evaluation's training and capacity-building efforts prepare new leaders in M&E

For nearly a decade, MEA-SURE Evaluation has facilitated training and capacity-building activities to enhance the development of monitoring and evaluation (M&E) skills among health-sector professionals around the globe. Through our training workshops and master's degree programs, we prepare individuals to



We strive to foster the development of M&E technical skills and data use. A key component of MEASURE Evaluation's capacity-building strategy is to work closely with policymakers, program managers, M&E specialists, and community leaders in the public health arena on the use of M&E tools and methods, and how to monitor and evaluate programs within their own systems. This investment has benefited not only individuals we've helped train, but also the national programs, governmental organizations, educational institutions, and NGOs in which they work, as well as our regional university and training institute partners.

Master's Programs

MEASURE Evaluation provides fellowships for students in M&E-focused master's degree programs at public health schools in universities in Asia, Africa, and Latin America. These master's degree programs are designed to develop cadres of individuals who are prepared for careers in M&E and to provide comprehensive training in the M&E of health-related programs in developing countries. Participants undertake training in the theory and practice of M&E, as well as in epidemiology, demography, reproductive health, and survey



methods to prepare them for future M&E responsibilities. We have sponsored 94 fellows so far; more than 400 other students have completed the M&E tracks at those schools.

Regional M&E Workshops

Since 1998, MEASURE Evaluation has offered 59 workshops in Asia, Africa, Latin America, and the United States, attended by almost 1,529 individuals. These workshops, from two to four weeks long, provide an intensive and rapid transfer of M&E concepts, tools, and skills to mid-level health professionals who have M&E responsibilities within their organizations.

Participants learn how to build and apply technical, statistical, communication, strategic planning, and data-use skills. Workshop topics include M&E of population, health and nutrition programs, HIV/AIDS, program impact evaluation, RHIS and tuberculosis.

"I was part of the Nutrition Group during the group assignment in Ethiopia. I am adopting the approach used in the group assignment to develop the M&E plan for Nutrition in Southern Sudan. It is only yesterday September 27, 2007, that I convened a meeting with the Nutrition Technical Working Group and we have formed a small task force of five member institutions (Mohr/ UNICEF/ WFP/ Tear fund/ ACFUSA) to look closely into the module we developed in Ethiopia and work out which components/tools will be adopted. Once this is done, the task force will draw out the plan of how to engage stakeholders in a planning process that follows some of the tools selected then develop indicators based on the processes stipulated. This is to ensure we contribute practical indicators to the overall health M&E framework."
