M&E of PHN Programs

MEASURE Evaluation provides regional training workshops to meet a great need in developing countries for professionals with M&E skills

Demand for monitoring and evaluation (M&E) skills is particularly acute in government agencies and local nongovernmental organizations that implement population, health, and nutrition (PHN) programs. Unfortunately, there are very few places in developing countries where professionals can seek training to increase their M&E skills.

One of MEASURE Evaluation's capacity-building activities is aimed at establishing partnerships in developing countries with selected universities and training/research centers to offer M&E training programs and related activities. In order to build the capacity of professionals, MEASURE Evaluation and its institutional training partners offer three-week non-degree courses that provide training in the design and implementation of M&E systems that coordinate the collection of information necessary to inform decisions related to PHN programming. Planning for and effectively communicating strategic information are integral components of the course modules.

To deliver these workshops, MEASURE Evaluation relies on partnerships with training institutions, including Addis Ababa University in Ethiopia, Centre Africain Etudes Supérieures en Gestion (CESAG) in Senegal, and Public Health Foundation of India (PHFI) in India.

M&E skills are crucial to the successful design, implementation, monitoring, and evaluation of PHN programs. To provide accessible, short-term, state-of-the-art training in M&E to professionals worldwide, MEASURE Evaluation offers these periodic short-term non-degree training courses that cover core concepts, tools, techniques, and practical applications in M&E of reproductive health, maternal and child health, nutri-



tion, and HIV/AIDS programs. In workshops held in Africa, malaria and tuberculosis programs are also covered. Workshops are held in Ethiopia, Senegal, and India. In previous years, workshops have been offered in Thailand, Mexico, and Uganda.

WORKSHOP CONTENT

These courses include strategic information; programdesign frameworks; data systems and indicators; impact evaluation designs; building performance M&E plans; data-collection methods; utilization and feedback of M&E results; M&E of maternal health, child health, reproductive health/family planning; sexually transmitted diseases/HIV/AIDS and nutrition programs; and data dissemination and information use.

Sessions on computer software (e.g. SPSS and Power-Point) are available for participants who are in need. Hands-on experience in designing M&E plans is offered through in-class exercises and small group work throughout the workshop. Participant groups present the results of their projects during the final day of the workshop.
